summary of the discussion:

1. Special Nutrition Assistance Program (SNAP): According to USDA, funding is currently available but, USDA will **NOT** reimburse State Governments should they use their funding to cover the cost of their participants benefits.
2. Women Infant Care (WIC): States are currently struggling to fund WIC and they are looking forward to the temporary reallocation of funds.
3. Child and Adult Care Food Program (CACFP): USDA has indicated that funds are available and funding authorizations have been provided to reimburse the Programs. Virtual Monitoring Waivers are available should States have the need. States should be receiving notifications of October and November 2025 authorizations. In short, **CACFP is not in a crisis at this time.**
4. Updates: Management Evaluations of State Agencies will be delayed due to the shutdown. States are still required to conduct Administrative Reviews of their Sponsors.
